Terms and Conditions

- 1. Fees once paid will not be refunded, adjusted or transferred. Fee will not be adjusted to any other course.
- 2. To take any leave, a prior written application will have to be submitted 3 days before.
- 3. Course Extension will be considered only due to unavoidable reason.
- 4. It is being strictly mentioned that only placement Assistance will be given to student. We are not providing any kind of job Guarantee Claim.
- 5. Fees being charged are subject to change without giving any prior notice.
- 6. The identity card issued by the Head Quarter should be present with the students within the institute premises.
- 7. The student should attend all the theory and lab classes regularly because if a student remains absent for 5 consecutive classes, he/she shall be subjected to a cancellation of registration. In such a situation, the student will have to take a re-admission by paying a time of Rs. 300/-
- 8. The institute reserves the rights to claim any damages or penalty from the students in case of any damage caused either to its furniture, property, books, computers or any other material etc.
